

TWO DAY BUSINESS EVENTS IN LONDON

20 -21 May 2019

The Ministry of Energy, Commerce and Industry and the Cyprus Chamber of Commerce and Industry are organizing a delegation to London during the period 20-22 May 2019 to take part in a series of events aimed at the broad promotion of business relations between Cypriot businesses and the City UK. The delegation to London gains additional importance in view of the Brexit developments.

In particular the following events are being organized:

Participation in CITY WEEK UK 2019 (20-21 May 2019)

Cyprus is participating for the first time in the prestigious CITY WEEK as a Gold sponsor. CITY WEEK UK, now in its ninth year, is the premier gathering of the international financial services community and brings together policy makers and senior industry representatives from around the globe. It consists of two days of cutting edge conferences and seminars, providing unique networking opportunities for the Cypriot delegates with a pool of over 650 c-suit participants from around the globe.

High Level Networking Event and B2Bs with the British Indian Business Community (21 May 2019)

During this event, each Cypriot company will be given a 5 minute slot to present their company and services to the Indian Business Community. The audience will consist of a maximum of 50 high level participants from the Indian British Business community that are interested in potential business cooperation with Cyprus.

Following the presentations, all Cypriot delegates will take part in B2B meetings with relevant businesspersons.

By attending the two day events, Cypriot delegates will be entitled to:

- Take part in all sessions of City week UK (both days)
- Join in all networking receptions and lunches of CITY WEEK, providing thus a unique opportunity to network with a pool of 650 business people.
- Take part in the closed business event with the Indian community
- Make a 5 minute presentation of their company/services to the Indian community
- Take part in B2B meetings with the Indian Business Community

No travel agency has been chosen to organise the trip and delegates are free to make their own travel arrangements.
